### **CALL FOR PAPERS**

Surveillance practice is future-oriented. Whether deployed by the state, the private sector or both, surveillance concerns itself, in part, with what is yet to come. These futures range from the prediction or pre-emption of risk, danger, profit, population dynamics and consumption patterns, and the projection and protection of identities online, to the use of techniques to bring about geopolitical change. Throughout the history of surveillance practices, in key sites and at different scales across the world, multiple futures have been made possible and others have been lost. The regulation of surveillance, as well, has a future, as new surveillance techniques and practices challenge the rules and regulatory instruments of the past.

Surveillance studies is now established as an academic field of study. It reaches across disciplines, theoretical perspectives and international boundaries. What is its future and what kind of work needs to be done?

This conference calls for papers which examine the many facets of this fascinating issue. Papers are invited on (but not limited to) the following topics:

  - Modes of visualization and emerging technologies
  - The surveillance imaginary
  - Surveillance, identity and becoming
  - International comparative perspectives on surveillance
  - Political economies of surveillance

  - The future of surveillance regulation
  - The future of surveillance studies
  - Local/Global geographies of Surveillance
  - Mapping and controlling territories

- The main conference will run all day from **3<sup>rd</sup> to the 4<sup>th</sup> April**.
  - A **special session for doctoral students** will be held in the afternoon of the **2<sup>nd</sup> of April**.

If you are a doctoral candidate and wish to join the doctoral session please indicate this on your abstract. In the doctoral session students will present papers alongside a series of short research workshops provided by more established academics.

## **FEES AND LOCAL INFORMATION**

This is a non-residential conference and participants will need to make their own arrangements for accommodation (we will provide advice for this in due course). The Conference will be held at the Kenwood Hall Hotel, Sheffield, UK.

The Conference Fee is £275 per person, which includes refreshments and lunch and an optional £50 two years' membership of Surveillance Studies Network. The membership fee will be used to promote the charitable activities of the Surveillance Studies Network, support the continued publication of the Journal of Surveillance and Society and give other benefits to members.

There will be a formal conference dinner at an additional charge.

We are hoping to offer ten reduced-fee places for post-graduate students wishing to give a paper or present a poster display of their research. If you wish to apply for this please register your interest as soon as possible and send an abstract by 7<sup>th</sup> January 2012. Allocation to these strictly limited places will be based on the quality of the abstract/ research description and on a first-come-first-served basis.
